The objective of this verification was to ensure that the GHG statement is materially correct and conforms to all relevant criteria. The GHG statement is the responsibility of JB Hunt. A summary of the GHG statement is as follows:

- GHG-related activity: Transportation Services
- GHG statement: Calendar Year (CY) 2024
- Criteria:
 - ISO 14064-3:2019 “Greenhouse gases –Part 3: Specification with guidance for the validation and verification of greenhouse gas assertions”
 - World Resources Institute and World Business Council for Sustainable Development’s Greenhouse Gas Protocol Corporate Accounting and Reporting Standard (GHG Protocol)
 - GHG Protocol Scope 2 Guidance
 - GHG Protocol Scope 3 Guidance
 - Other supplemental CDP requirements

The data and information supporting the GHG statement were historical in nature.
